In addition, it is hereby notified that three directors, including the President, from Sammy NetWork have been appointed as of February 8, 2013.

Butterfly develops many services such as comprehensive pachinko and pachislot portal service "Moba7" and other social games for "Mobage" operated by DeNA Co., Ltd.
