On Thursday, November 20, PARADISE SEGASAMMY Co., Ltd. (Representative: Choi, Jong Hwan) ("PARADISE SEGASAMMY"), a joint venture established by SEGA SAMMY HOLDINGS INC. (Headquarters: Minato-ku, Tokyo: Hajime Satomi, Chairman of the Board and Chief Executive Officer) (the "Company") with Paradise Co., Ltd. (Representative: Phil-Lip Chun, Chairman) ("Paradise"), which conducts operation of casinos and management of hotels and spas in the Republic of Korea, held a groundbreaking ceremony for PARADISE CITY that will be South Korea's first-ever fully-fledged integrated resort (IR), and commenced construction work with the aim of beginning operations in the first half of 2017.

The aim is for PARADISE CITY, which will be developed in South Korea's Incheon International Airport International Business Center, to be an entirely new and unique integrated resort combining the experience and expertise that Paradise has accumulated over 40 years in diverse sectors, such as casino facility operation and the tourism business, with the Company's capacity to plan and develop a wide range of entertainment. Bringing together a luxury hotel, boutique hotel, casino, commercial facility, convention hall, premium spa and more on its 330,000m<sup>2</sup> site, it is scheduled to open in the first half of 2017 as South Korea's first fully integrated resort able to be enjoyed by everyone, from children to adults.

PARADISE CITY will feature outstanding transportation access such as being located a 10-minute walk from Incheon International Airport—Asia's largest hub airport, boasting 41.67 million passengers per year—and a direct rail connection is also planned to run from the airport. Furthermore, it will be equipped with the functions required to hold meetings, incentives, conferences and exhibitions (MICE), including a 711-guest room luxury hotel, South Korea's largest casino for foreigners and a convention hall. It will also function as a major center for promoting Korean culture—for example, by providing Korean pop culture content through live events at a culture hall, a shopping zone and the like.

Thanks to the customer-attracting capacity of an international hub airport, the outstanding accessibility of the site, and facilities that can accommodate all kinds of travelers (business, leisure, etc.), PARADISE



CITY aims to become a central presence in Northeast Asia, visited not only by South Koreans but also by many tourists from other countries, including China and Japan.

Having identified the integrated resort (IR) business as a future growth field, the Company aims to gain significant profit from PARADISE CITY. In addition, it intends to build up the diverse know-how and expertise required to develop and operate integrated resorts within the group through this project, leading to further expansion of its business and revenues.
