SAMMY CORPORATION (Headquarters: Toshima-ku, Tokyo, President and COO: Keishi Nakayama) and KYORAKU Industrial Co., Ltd. (Headquarters: Nagoya City, Aichi Prefecture, President and CEO: Yoshinori Enomoto) announce that they have agreed to collaborate on a project toward revitalizing the pachinko and pachislot machine industry.

The pachinko and pachislot machine industry remains an industry of the largest scale in Japan's leisure market, with a market scale of 21 trillion yen\*1 and 15.8 million participants\*2 as of 2008. However, market scale, installations and sales volumes as well as the number of facilities have each been on a declining trend, due in part to the lack of innovative machines based on new rules implemented in July 2004 as well as pachinko and pachislot machine manufacturers' inclinations toward high volatility machines.

The companies will jointly implement effective promotional activities in line with the "40<sup>th</sup> Year of Ashita no Joe".

The companies will contribute to the healthy development of the pachinko and pachislot industries by supplying unprecedented entertainment through this project.
